1. India has applied for financing from the Asian Development Bank (ADB) toward the cost of **Bihar Urban Development Investment Program – Tranche 2**. Part of this financing will be used for payments under the contract named above. Bidding is open to eligible bidders from eligible source countries of ADB as described in Section 5 of the Bidding Document.

2. The **Bihar Urban Infrastructure Development Corporation Limited** (BUIDCo., hereinafter referred to as the "Employer"), a Government of Bihar undertaking, represented by its Managing Director, invites sealed bids from eligible bidders for the **Improvement of Water Supply for Gaya Municipal Corporation (the "Works")**.

3. **International Competitive Bidding (ICB)** will be conducted in accordance with ADB's "Single-Stage: Two-Envelope" bidding procedure and is open to all Bidders from eligible countries as described in the Bidding Document..

4. To be qualified for the contract package, the bidder should as a minimum meet the following requirements:

- Average annual construction turnover for last three years equal to or more than INR 1,117 million or US\$ 18.62 million calculated as total certified payments received for contracts in progress or completed within the last 3 financial years;
- Participation as contractor, management contractor, or subcontractor, in at least one (1) contracts within the last seven (7) years, each with a value of at least INR 1,557 million or US\$ 26 million, that have been successfully or are substantially completed and that are similar to the proposed works and services;
- Meet other financial and experience requirements as indicated in the Bidding Document.
