1. The Bihar Urban Infrastructure Development Corporation Ltd (BUIDCO), for and on behalf of the Owner in the State of Bihar, India invites bids from eligible Bidders for the work comprising the following works in Digha and Kankarbagh zones of Patna, State of Bihar, India:

**Digha Zone:**

- (i) Design, build and finance Sewage Treatment Plant of capacity **100 MLD** including SCADA and online monitoring system, effluent channel (0.5 km) and all appurtenant structures and allied works. The period for design, build, testing and commission is **21 months**;
- (ii) Design, build and finance Interception & Diversion Works including tapping of MandiriNalla and Rajapur-AnandipurNalla, KurjiNalla at two locations, two (2 nos) Sewage Pumping Stations, along with rising mains and all appurtenant structures; Period for design, build, test and commissioning in **21 months**;
- (iii) Survey, review the designs, redesign where necessary and build new sewerage network of about **303 km** length including survey, design, construction of 02 nos. pumping stations including SCADA system for pumping stations, and all appurtenant structures; Period for redesign, build, testing and commission is **31 months**;
- (iv) Operation & maintenance of the complete works of Sewage Treatment Plant, Interception & Diversion Works and all appurtenant structures and allied works at Digha in Patna, State of Bihar, India. The period for operation and maintenance is **15 years**, followed by transfer of these complete works at the end of concession.
- (v) Operation and maintenance of sewerage network and pumping stations till end of concession at Digha in Patna, State of Bihar, India, followed by transfer of these complete works at the end of concession.

**Kankarbagh Zone:**

- (i) Design, build and finance Sewage Treatment Plant of capacity **50 MLD** including SCADA and online monitoring system, effluent channel (1.6 km) and all appurtenant structures and allied works. The period for design, build, testing and commission is **21 months**;
- (ii) Design, build and finance Flow Diversion Works including weir arrangement on the existing Jogipur Canal/ Drain, diverting flow and all appurtenant structures and allied works. The period for design, build, testing and commission is **21 months**;
- (iii) Survey, review the designs, redesign where necessary and build new sewerage network of about **150 km** length including survey, design, construction of 02 nos. pumping stations including SCADA system for pumping stations, and all appurtenant structures. The period for redesign, build, testing and commission is **31 months**;
- (iv) Operation & maintenance of the complete works of Sewage Treatment Plant, Flow Diversion Works and all appurtenant structures and allied works at Kankarbagh in Patna, State of Bihar, India. The period for operation and maintenance is **15 years**, followed by transfer of the complete works at the end of concession.
- (v) Operation & maintenance of sewerage network and pumping stations till end of concession at Kankarbagh in Patna, State of Bihar, India, followed by transfer of the complete works at the end of concession.
