

**Scope of Work-** This project is based on Output and Deliverables. The object of this EOI is to select qualified firm who will provide short term, Mid-term and long term planning based on Scientific Data, Scientific analysis, contour mapping, gravity flow and Hydraulic data for solution to make Patna free from water logging problem. The Consultant will carry out required investigation, design, prepare feasibility report, Preliminary design report, detail project report including prioritization, issue bid invitation, clarification to the implementry bidder queries, bid evaluation, selection of contractor/ Implementing agency, award of contract, but supervision during construction phase is not their scope.

**B) Eligibility criteria-**

- i) Maximum two members in association and joint venture will be allowed. Lead partner and consortium both will fill not less than 50 % of eligibility criteria and lead partner must be defined & lead partner will be responsible for this assignment if any dispute arises.
- ii) In any one year minimum annual financial turnover of 200 Crore in last five years. Consultant will submit last five years audited balance sheet to see their financial stability.
- iii) Three completed projects having similar topography of project area covering at least project area of 130.03 Sq. KM.
- iv) Only sewerage scheme and storm water drainage scheme project will be considered and ongoing project will be considered only if final DPR submitted for their administrative approval. (completion/ Submission certificate must be attached).
- v) Foreign consultancy firm are also required to full fill same eligibility criteria which is ask in this EOI.
