Introduction:-

Bihar Urban Infrastructure Development Corporation Ltd., (BUIDCo) is entrusted to carry out operation and maintenance of Buddha Smriti Park, Patna.

Buddha Smriti Park is located on Frazer Road near Patna Junction in Patna. This park has been developed by the State Government of Bihar.

The central attraction of this park is the Stupa, known as Patliputra Karuna Stupa, 200 feet high, situated in the middle of the park. This 22 acre park is located in the heart of city. Inside Karuna Stupa, relies of Lord Buddha is pleads.

The park is well equipped with the electrical appliances. The installation of AC Plants, Submersible water pumps, bollards, high mast and other decorative lights, operation of Laser show have increased aesthetic value of the park.

Scope of work:-

One time servicing of Servicing of 2500 KVA over load Transformer including refilling of electric oil and related all alied parts installed at Buddha Smriti Park Patna.

Any replacement of machinery parts as required making the Transformer functional, the contractor will have to procure, supply and assemble the same from the same original manufacturer.

SPECIAL CONDITIONS OF CONTRACT

- 1. The agency must visit site and inspect the Transformer before quoting the price for one time servicing.
- 2. The selected agency, contractor, will be responsible for fully functional of the Transformer throughout the Defect liability period. Any replacement of machinery parts as required making the Transformer functional, the contractor will have to procure, supply and assemble the same from the original manufacturer.
- 3. In case of any failure in the Transformer, the agency shall have to attend the issues within 3 hours from intimation about the problem from BUIDCo.
- 4. All equipment provided by the contractor shall be of proven efficiency and shall be operated and maintained at all times in a manner acceptable to the Engineer-in Charge.
- 5. In case of successful tender, the amount of the earnest money will be transferred to the initial security deposit (Performance Guarantee) and balance amount will be deposited by the contractor to cover up five percent (5%) security deposit before execution of the agreement and further five (5%) security deposit (Performance Guarantee) will be deducted from each running bill.
- 6. The rate quoted by the tenderer will be inclusive of all cost of materials, transport charges up to the work site with loading and unloading involved at various work sites, royalty and all type of state and central taxes. The complete rate as above only will be considered by the BUIDCo.
- 7. Conditional tender shall be outright rejected.
- 8. Before using the material in works, samples of material are got to be approved from BUIDCo.
- 9. In the event of any loss of the govt. articles the value of the articles shall be recoverable from the contractor.
