- 4. Conditional Quotation shall be outright rejected.
- 5. In the event of the Quotation being submitted by a firm in must be signed by each member or by a person holding the power of attorney authorizing him to do so. The partnership deed of the firm should be enclosed in the Quotation lacking which the quotation will be rejected.
- 6. Contract duration for Paste Control is One year. Further which may extended based upon scarification performance.
