

9. Contractors desiring to participate in this tender shall have to get registered which e-procurement on www.eproc.bihar.gov.in so that he has user ID, password and a valid digital signature. For more details contact BSEDC help desk, M/22, Bank of India building, Road No.- 25, Sri Krishna Nagar, Patna, 800001.
10. "BSEDC" Processing Fee is mandatorily to be paid through online mode i.e. Internet Payment gateway (Credit/Debit Card, Net banking, NEFT/RTGS."
11. "Tender documents along with necessary online payments must be submitted through e-Procurement portal www.eproc.bihar.gov.in before the date and time specified in the EOI. BUIDCO doesn't take any responsibility for the delay/ Non Submission of Tender/ Non Reconciliation of online Payment caused due to Non-availability of Internet Connection, Network Traffic/ Holidays or any other reason."
12. The Contractors shall have to submit cost of tender document, i.e. Cost of **BOQ** in form of **DD** of any nationalized bank in favor of **Executive Engineer (Mech.), South Bihar (Works Division), Buidco, Patna**. The earnest money shall be in the form of N.S.C., 3/5 years post office time deposit or 3/5 years time deposit of any nationalized bank having branch in Patna, in favour of **Executive Engineer (Mech.), South Bihar (Works Division), Buidco, Patna**. Tenders not accompanied with earnest money as per above instructions are liable for rejection. Successful tenderers shall be informed by this office to have enter into an agreement within seven (7) days from the date of being called upon to do so after depositing such amount to make security money to five (5%) percent of value of contract including earnest money as security money. Failure in compliance of the agreement in time will be liable for forfeiture of earnest money & cancellation of Work order. 5 (Five) % security will be deducted from each running bill making SD to 10% (Ten Percent). The security deposit money will be refunded after two months from the date of successful completion of the work.
13. A scanned copy of the instrument(s) for Earnest Money and cost of tender document (B.O.Q.) to be uploaded along with the tender documents.
14. The Contractors must use MS Office- 2003 version. File size should be less than 6MB and should be in M.S. word, M.S. Excel, **PDF** and **JPEG** Formats.
15. No claim shall be entertained on account of disruption of internet service being used by Contractors. Contractors are advised to upload their tender documents well in advance to avoid last hour's technical snags.
16. Corrigendum/Addendum, if any, will be published only on the website www.eproc.bihar.gov.in itself.
17. Annual turnover during preceding two consecutive financial years which should be minimum Rs. 25.00 (Twenty Five Lac) only.
18. The tender shall be received in two bid systems (i) Technical bid (ii) Rate bid. The technical bid shall contain earnest money, PAN card, GST registration, registration certificate with central or

state Govt. or PSU, experience certificate for last 3 years of similar work, Electrical contract license, Labour registration certificate, Character Certificate, affidavit regarding blacklisted & debarred from Central/ any State Government/ PSU under Central or any State Government, etc. The rate bid documents will be contain in the BOQ. in which only rate would be quoted. The technical bid will be opened & assessed first and subsequently the rate bid of technically successful tenderers shall be opened.

19. If the tenderer is not registered with BUIDCo, they will have to registered with BUIDCo after issuing LoA before agreement.
20. The bidder will have to handover the Trolley Mounted Pump & all accessories to BUIDCo in running condition after operational period, failing which last payment shall not be released.
21. Energy bills will be paid by BUIDCo.
22. During power interruption diesel pump set will be operated. The fuel & lubricating oils will be provided by the bidder. Proper Log-Book shall be maintained and shall be deposited to department.
23. Since the job of BUIDCo is of urgent nature, the bidder shall be responsible to rectify the break-down within a resonable time failing which a penalty of double the repair value shall be charged which will be deducted from their bill of the corresponding month.
24. The bidder will be responsible for safety and security of TDPS and staff working there.
25. If any of documents mentioned in sl. no. – 18 will not be uploaded by the tenderer then their tender shall be rejected out rightly and their financial bid shall not be opened.
26. The tenderer may download BOQ. for any group or all the group as they desire so.
27. Chief Engineer, South Bihar, Drainage, Sewerage & Drinking water, Buidco, Patna reserves the right to accept or reject any or all group of tender without assigning any reason thereof or to distribute the work among technically successful tenderers for which tenderer shall have no claim.
28. Conditional tender will not be accepted.
29. Tenderers shall have to complete the work within time schedule as mentioned in column-7 of above table. Time schedule as mentioned above shall mean the time from the date of issue of work order.
30. If any dispute or difference arises in the interpretation of the specification, bill of quantities, tender documents, schedule of prices or any other matters with the contract, the decision of the Chief Engineer, South Bihar, Drainage, Sewerage & Drinking water, Buidco, Patna shall be final and binding upon the tenderer concerned.
31. Payment against bill for the work is subject to allotment of fund.
32. The contractor shall provide all necessary assistance to the Engineer's representative and his staff in carrying out their duties of checking and setting out, inspecting and measuring the work.
33. The tenderers are advised to visit the work sites and see himself the site and ground conditions in all respect including availability of labours, approaches, availability of water, electricity, materials and all other matters affecting the work before submitting the tender.
34. 1% amount shall be deducted from each bill against labour cess as per rule.
35. The SSI unit will be facilitated as per Government rule.
36. The electrical contract license is mandatory for the works issued by Govt. of Bihar.
37. The bidder shall produce documentary evidence for meeting the following qualification criteria along with technical bid.
 - (a) The annual turnover in anyone year during last three years of the contractor shall be minimum Rs. 25 (Twenty Five) Lakh.
 - (b) The bidders should have a minimum of 3(Three) years experience in maintenance / repair and technically sound skilled manpower to quick attend the breakdown
 - (c) List of technical man power working with the firm.
38. The interested bidders are advised to visit the TDPS & ware house before filling the tender.
39. Any legal dispute with the contractor will be settled with court of law within the area subject to Patna Jurisdiction.
