the bidder.

The Contractors shall have to submit cost of tender document, i.e. Cost of BOQ in form of DD of 14. any nationalized bank in favor of Executive Engineer (Mech.), South Bihar (Works Division), Buidco, Patna. The earnest money shall be in the form of N.S.C., One, two or three years post office time deposit, D.D. or 5 years time deposit of any nationalized bank having branch in Patna, in favour of Executive Engineer (Mech.), South Bihar (Works Division), Buidco, Patna. Tenders not accompanied with earnest money as per above instructions are liable for rejection. Successful tenderers shall be informed by this office to have enter into an agreement within seven (7) days from the date of being called upon to do so after depositing such amount to make security money to five (5%) percent of value of contract including earnest money as security money. Failure in compliance of the agreement in time will be liable for forfeiture of earnest money & cancellation of Work order. 5 (Five) % security will be deducted from each running bill making SD to 10 (Ten)%. The security deposit money will be refunded after two years from the date of successful completion of the work.

16. The tender shall be received in two bid systems (i) Technical bid (ii) Rate bid. The technical bid shall contain earnest money, PAN card, GST registration, registration certificate with central or state Govt. or PSU, experience certificate for last 3 years of similar work, Electrical contract license, Labour registration certificate, affidavit regarding blacklisted & debarred from Central/ any State Government/ PSU under Central or any State Government, etc. The rate bid documents will be contain in the BOQ, in which only rate would be quoted. The technical bid will be opened & assessed first and subsequently the rate bid of technically successful tenderers shall be opened.

17. Earnest money in any form as prescribed in rule 161 of the PWD code and duly endorsed/pledged in favour of Executive Engineer (Mech.), South Bihar (Works Division), BUIDCo, Patna can be in any of the following shapes or combination thereof:-

(a) Fixed Deposit receipt of Nationalized /Scheduled Bank and valid for 180 days after last date of receipt of tender.

(b) Post Office/Saving Bank Passbook.

(c) One, two or three years Post Office time deposit.

(d) NSC issued within the State of Bihar.

The above instrument(s) shall remain valid for the minimum period of 180 days after last date of receipt of tender.

Bid Processing fees and Form fees/ BOO Fee: -18.

- (a) Bid Processing Fees is mandatory to be paid through online mode i.e. Internet payment gateway (Credit / Debit Card), Net banking, NEFT/RTGS".
- (b) BOQ Fee is mandatory to be paid through Demand Draft (DD) in favour of Executive Engineer (Mech.), South Bihar (Works Division), BUIDCo, Patna.
- (c) Earnest money Deposit (EMD) can be paid through manual mode as above mention. In manual mode of payment of EMD, the original hardcopy of the EMD of any other instrument that should be submitted in the tendering authority office within the next working day after tender.
- (d) Bids along with necessary online payments must be submitted through e-Procurement portal www.eproc.bihar.gov.in before the date and time specified in the NIT. The department doesn't



take any responsibility for the delay/Non-Submission of Tender/Non-Reconciliation of online Payment caused due to Non-availability of Internet Connection, Network Traffic/Holidays or any other reason. "BSEDC processing fee has to be paid through e-payment mode only. EMD &

Bidders/ Contractors can access tender documents on the website and must fill them and submit Tender/BOQ fee paid through offline mode". the completed tender documents in electronic form on the website itself. Bidders/ Contractors shall attach scanned copies of all required papers, DD, EMD and certificates as required in the 19. eligibility criteria. All the uploaded documents shall have the signature of bidder or their authorized signatories. The scanned copies should be of the original papers and certificates.

Corrigendum/ Addendum, if any, will be published on the website itself. In the unlikely event of the server for www.eproc.bihar.gov.in being down for more than two consecutive hours (in the period from midnight to closing time for receipt of tenders) on the last 20. date of receiving of bid, the last date of the same shall automatically be extended to next working 21. day till the last receiving time stipulated in the original NIT.

The bidders are requested to check their file size of uploaded documents at the time of submission & they should ensure that work file is uploaded. If they feel that the complete file is not uploaded, 22. then they should click on cancel & update the same before submission. The bidders should satisfy

themselves of Download ability/visibility of the scanned & uploaded file by them.

The bidders are directed to zip their files using WinZip or WinRAR software only. Other formats 23. of zipping will not be accepted and will be rejected.

The bidder must use MS Office-2007 or lower version.

File size should be less than 5MB and should be in MS Word, MS Excel, PDF and JPEG formats. 24.

No claim shall be entertained on account of disruption of internet service being used by bidders. 25. Bidders are advised to upload their bids well in advance to avoid last minute technical snags. 26.

The bidder should not be blacklisted or debarred by Centre/State Govt. or its agency/ utility/ enterprises. Scan copy of an affidavit on Rs.100+5 stamp paper of this regard must be uploaded in 27. bid.

The conditional tender will not be accepted.

The tender will be received in two bid systems. i.e. Part - I Technical & Part -II Financial. 28.

The quantity and amount of BOQ may increase or decrease for which the tender will have no 29. 30.

Taxes &Cess deduction: - Taxes including Seiginiorage Fee will be deducted from each bill of the contractor as applicable. One percent cess will be deducted from each bill in the head of welfare 31.

Regarding any information of the proposed work bidder should contact the Executive Engineer (Mech.), South Bihar, BUIDCo (Works Division), Patna/Superintending Engineer, BUIDCo, 32. Patna on any working day before submission of bid.

Rate quoted more than 10% below of BOQ rate, will be outright rejected

If the tenderer is not registered with BUIDCo, they will have to registered with BUIDCo after 30. 31. issuing LoA before agreement.

Bidders have to submitted up to date Character Certificate.

If any of documents mentioned in sl. no. - 16 will not be uploaded by the tenderer then their 32. tender shall be rejected out rightly and their financial bid shall not be opened. 33.

The electrical contract license is mandatory for the works issued by Govt. of Bihar. 42. The bidder shall produce documentary evidence for meeting the following qualification criteria along with technical bid.

(a) The annual turnover in anyone year during last three years of the contractor shall be minimum Rs. 25 (Twenty Five) Lakh.

(b) The bidders should have a minimum of 3(Three) years experience in maintenance / repair and technically sound skilled manpower to quick attend the breakdown.

(c) List of technical man power working with the firm.

(d) Work experience during last three years of handling similar work.

The interested bidders are advised to visit the plant before filling the tender about make and 43. conditions of the existing pump sets, electrical installations etc. No claim will be entertained for pre-existing defects in any of the electro-mechanical equipment. 44.
