- 1. 'Namami Gange Programme', is an Integrated Conservation Mission, approved as 'Flagship Programme' by the Union Government in June 2014 with budget outlay of Rs.20,000 Crore to accomplish the twin objectives of effective abatement of pollution, conservation and rejuvenation of National River Ganga. The National Mission for Clean Ganga (NMCG) (Department of Water Resources, River Development & Ganga Rejuvenation, Ministry of Jal Shakti, Government of India and wherever else applicable in the bid document) is the funding agency for Namami Gange Programme and intends to apply a part of the said budget outlay towards payments under the contract for work detailed below.
- 2. Qualification requirements as listed briefly below are required to be fulfilled by the bidder. [Bidders are advised to refer to the bidding documents for complete details.]

Financial:

- a. The Bidder shall demonstrate that it possesses a net worth equivalent to minimum of INR 3.10 Crore. in each of the last three financial years preceding the date of submission of bid.
- b. The Bidder shall demonstrate by submitting along with its bid, a banker's certificate that it has available cash credit facility equivalent to minimum INR 3.10 Crore as on the date of submission of bid.

However, in absence of such certificate the bidder shall provide an undertaking that (As per attached format) to submit a banker's certificate that it has available cash credit facility equivalent to minimum INR 3.1 Cr. Within 15 days of issuance of Letter of Award (LOA) before signing of agreement.

Technical:

- a. The Bidder shall provide evidence that it has Designed, developed, built, tested and commissioned at least one STP of 4.8 MLD or at least two STP of 3.6 MLD or at least three STP of 2.4 MLD during last 7 years preceding the month of publication of NIT.
- b. The bidder or his nominated sub-contractor has successfully commissioned at least one Sewage Treatment Plant with the same technology as proposed for this contract for the lowest STP capacity mentioned in clause 1.4 (a) 1. above, operating successfully for a period of 1 year during the last 7 years preceding the month of publication of NIT.

- c. The Bidder has the experience in operating and maintaining successfully at least one STP of 4.8 MLD or at least two STP of 3.6 MLD or at least three STP of 2.4 MLD for 1 year over the last 7 years preceding the month of publication of NIT.
- d. The treatment technology proposed for this contract has been adopted (not necessarily built by the bidder) in at least 3 locations during last 7 years preceding the month of publication of NIT and that such STP has been operating successfully (meeting the required performance standards and environmental norms specified in the Contract) for a period of minimum 2 years over a period of last 7 years preceding the month of publication of NIT.
- e. It has designed, developed, Built, tested and commissioned Sewerage Network and Pumping Station(s) of 1.8 KM length collectively from maximum 3 projects during the last 7 years preceding the month of publication of NIT of which 0.9 KM should be equal to or above 300 mm diameter pipe.
- f. The bidder or his nominated sub-contractor has operated and maintained Sewerage Network and pumping station of 1.8 KM length collectively from maximum 3 projects during 1 year over the last 7 years preceding the month of publication of NIT
- 3. Bidding will be conducted through the National Competitive Bidding and is open to all eligible bidders. Bids will be received only through (Through e-procurement mode only www.eproc.bihar.gov.in).
