5. To be qualified for the contract package, the bidder should as a minimum meet the following requirements:

- Average annual construction turnover for last three years equal to or more than average annual construction turnover of USD 11 million or INR 700 million calculated as total certified payments received for contracts in progress or completed within the last 3 years;
- Participation in at least two (2) contracts that have been successfully or are substantially completed within the last seven (7) years and that are similar to the proposed works and services, where the value of the Bidder's participation exceeds INR 520.00 million or USD 8 million;
- Meet other financial and experience requirements as indicated in the Bidding Document.
