

- 3. अनुभव प्रमाण—पत्र के सत्यापन हेतु बुडको के पत्रांक—2106 दिनांक—21.03.2020 से Executive Engineer, Public Health Works Division Gujrat Water Supply & Sewerage Board को पत्र भेजा गया।
- 4. Executive Engineer, Public Health Works Division Gujrat Water Supply & Sewerage Board द्वारा पत्र संख्या— AB-1/ Okha UGD/ 431 दिनांक—30.03.2020 से बताया गया कि वर्णित योजना OKHA town Under Ground Drainage Project, District: JAMNAGAR में M/s LC Infra Projects Pvt. Ltd. द्वारा कुल 10 Pumping Station का निर्माण किया गया था, जिसकी कुल क्षमता 32.51 MLD (1.60MLD+1.62MLD+0.28MLD+1.15MLD+7.70MLD+7.70MLD+9.82MLD+0.52MLD+1.15MLD+0.97MLD=3 2.51MD) थी।
- 5. दिनांक—24.09.2020 को श्री पवनभाई पटेल द्वारा ई—मेल के माध्यम् से Complaint समर्पित किया गया, जिसमें उनके द्वारा निम्नवत उल्लेख किया गया:

"M/s LC Infra Projects Pvt. Ltd. has submitted a Completion Certificate of 73.74 MLD Pumping Station from the respected Department "Gujarat Water Supply and Sewerage Board, Public Health Works Division, DevBhumi Dwarka, Jamkhambhaliya" which is false & fabricated.

In this completion certificate that this has done 10 nos. Pumping Station at different places of different size, which even if combined, it is total of 32.51 MLD, which is not even half of the Completion Certificate submitted by them. This has not been done by mistake as contractors before taking completion certificate every one checks the data written there, how can they receive the work done certificate which they have not done. They have done this type of fraud many times as per the tender requirement. It can be checked from your side as well by asking the concerned Department regarding 73 MLD pumping station work of their submitted Completion Certificate".

"Along with the technical bid, you have signed and submitted the work done experience certificate issued by Executive Engineer, Gujrat Water Supply and Sewerage Board, Public Health Works Division, DevBhumi Dwarka, Jamkhambhaliya vide letter no.-AB-1/861, Dated 21.09.2018. As per the certificate M/s Laxmi Construction, Ahmedabad has completed construction of Pumping Station (including Wet Well) – 73.74 MLD under OKHA town Under Ground Drainage Project, District: JAMNAGAR.

In course of verification of experience certificate, BUIDCO issued letter to Executive Engineer, Gujrat Water Supply and Sewerage Board, Public Health Works Division, DevBhumi Dwarka, Jamkhambhaliya vide letter no.-2106 dated 21.03.2020. Reply from Executive Engineer, Public Health Works Division Gujrat Water Supply & Sewerage Board vide letter no. AB-1/Okha UGD/431 dated 30.03.2020 was received, wherein it is mentioned that M/s LC Infra Projects Pvt. Ltd. (formerly known as Laxmi construction) has built 10 nos. of Pumping Station with total capacity of 32.51 MLD (1.60MLD+1.62MLD+0.28MLD+1.15MLD+7.70MLD+7.70MLD+9.82MLD+0.52MLD+1.15MLD+0.97MLD=32.51MLD).

As per reply of Executive Engineer, P.H.W Division, JamKhambaliya, total 10 pumping station have been built having total capacity of 32.51 MLD, whereas in the certificate submitted by you, it is mentioned Pumping Station (including Wet Well) – 73.74 MLD. It clearly shows that the certificate submitted by you is misleading, false and fabricated. It is also to be mentioned that you have signed and self certified the certificate in which your pumping station experience is mentioned as 73.74 MLD which has been found false and wrong in verification.

It is evident that from above mentioned facts that you have falsely and fraudulently signed and submitted wrong certificate.

In this regard, you are requested to reply the showcause that why M/s LC Infra Projects Pvt. Ltd. should not be blacklisted as per clause no. 11.A (vii) of Bihar Contractor Registration Act 2007. Your reply must reach to the undersigned office by Nov 04, 2020 till 1:00 PM, failing which it will be assumed that you have nothing to say in this matter.

- 7. M/s LC Infra Projects Pvt. Ltd द्वारा दिनांक—03.11.2020 को स्प्य्टीकरण समर्पित किया गया है, जिसकी कंडिका—5, 6 एवं 7 में निम्नवत् तथ्य दिया गया है:—
 - "5. We had uploaded the certificate of Okha town Under Ground Drainage Project along with the bid documents as issued by the Executive Engineer.
 - 6. We came to know from your letter dated 31-10-2020 referred above that there is a discrepancy in total capacity of pumping stations mentioned in the certificate issued by the Executive Engineer and in confirmation of the Executive Engineer submitted under his letter No.AB-1/Okha UGD/431 dated 30-03-2020.
 - 7. We therefore requested the Executive Engineer to clarify in the matter vide our letter No.423 dated 03-11-2020. Copy of which is enclosed herewith. In reply to our said letter, Executive Engineer under his letter No. AB-1/Okha UGD/2090 dated 03-11-2020 clarified that total capacity of Pumping Station (including Wet Well) is shown as 73.74 MLD at Sr.No.27 on page-2 of the said certificate. The said capacity of 73.74 MLD is of total of all pumping stations to be executed as per scope of the contract. But while execution due to some changes, there was reduction in number of pumping stations and remained to 10 nos. pumping stations of total capacity of 32.51 MLD for all pumping stations. He also clarified that this discrepancy came to notice during course of verification of experience certificate asked under BUIDCo's letter dated 21-03-2020. Therefore by correcting the discrepancy; actual capacity of all the pumping stations executed was confirmed and reported to BUIDCo under his letter No. AB-1/Okha UGD/431 dated 30-03-2020. The copy of letter dated 03-11-2020 has also endorsed to your good self. However copy of the same is enclosed herewith for your ready reference".



- 8. M/s LC Infra Projects Pvt. Ltd. से प्राप्त जबाव का विश्लेषण किया गया एवं पाया गया कि M/s LC Infra Projects Pvt. Ltd. द्वारा 73.74 MLD Pumping Station under OKHA town Under Ground Drainage Project, District : JAMNAGAR. का अनुभव प्रमाण–पत्र लगाया गया, जबकि उनके द्वारा इस योजना अन्तर्गत वास्तविक में कुल 10 Pumping Staton जिसकी कुल Capacity 32.31 MLD का कार्य किया गया है। यद्यपि 73.74 MLD Capacity के Pumping Station का अनुभव प्रमाण–पत्र Executive Engineer, Gujrat Water Supply and Sewerage Board, Public Health Works Division, DevBhumi Dwarka, Jamkhambhaliya द्वारा निर्गत किया गया है, किन्तु M/s LC Infra Projects Pvt. Ltd. को इस अनुभव प्रमाण-पत्र को वास्तविकता के आधार पर संशोधित करना चाहिए था एवं 73.74 MLD Capacity के Pumping Station का अनुभव प्रमाण–पत्र निविदा के साथ समर्पित नहीं करना चाहिए था। M/s LC Infra Projects Pvt. Ltd. द्वारा किया गया कृत्य निश्चित रूप से गलत एवं दिगभ्रमित करने के उद्देश्य से संलग्न किया गया है।
